

What is considered income?

Counts as Income

- Federal taxable wages
- Tips
- Self-employment income
- Unemployment compensation
- Pandemic Unemployment Compensation (\$300/week)
- Social Security
- Social Security Disability Income (SSDI)
- · Retirement or pension
- Excluded (untaxed) foreign Income
- Investment income
- Alimony (only if divorce or separation finalized before Jan. 1, 2019)

Doesn't Count as Income

- Child support
- Gifts
- Economic impact/stimulus payments (come from the IRS as a result of the COVID-19 emergency)
- Veteran disability payments
- Supplemental Security Income (SSI)
- Workers' Compensation
- Proceeds from loans (like student loans, home equity loans, or bank loans)
- Child Tax Credit
- American Rescue Plan stimulus payments
- Golden State Stimulus payments



How Covered California Determines Your Premium and/or Cost Sharing Assistance



Covered California offers a 'Shop and Compare' tool which helps to determine if you and your family qualify for assistance.





To determine, you would need to provide four pieces of information to your enrollment counselor:

- 3. Permanent zip code
- 4. Age of each adult & child
